Work shifts are available 5 days a week or Monday, Wednesday, Friday or Tuesdays and Thursdays from 7am-8:30am and/or afterschool from 1-5pm. The program concludes in June and will open again in August for the 2023-24 school year. Program plans are pre-planned from and focus on reading, art, STEM and healthy lifestyle activities.

- Provide direct supervision of a group of youth ages 5-13 and always promote safety of members in programs.
- Serve as program mentors, providing group supervision, guidance, and role modeling to youth members.
- Effectively implement and administer consistent intentional programs.

- Establish positive relationships with Club members.
- Display a high level of professionalism, enthusiasm, energy and commitment.
- Follow BGCV policies and school procedures, including those related to medical and disciplinary situations, child abuse prevention, and emergency procedures
- Complete accurate program plans and reports in a timely fashion.
- Supervise the care and maintenance of department equipment.
- Ensure the daily cleanliness and safety of the site. Ensure that safety hazards are corrected.
- Participate and attends staff meetings, ongoing professional development, and other specified training and events as needed.
- Represent the Boys & Girls Club in a respectable and professional manner.

- Ability to implement quality programs that engage youth.
- Must possess strong organization and planning skills, emotional intelligence and adaptive learning capabilities.
- Ability to motivate youth, provide positive re-direction, and manage emotional/behavioral issues.
- Follow BGCV policies and procedures, including those related to medical and disciplinary situations, child abuse prevention, and emergency procedures.
- Strong communication skills, both verbal and written as well as possessing solid conflict resolution skills.
- Physical ability to lead and participate in active sports and games with Club members.
- Must have reliable transportation and meet dress code requirements.
- Must speak clearly and hear normal conversations as well as out of the ordinary noises
- Must be able to sit or stand for four plus hours per day.
- Must be able to stoop, bend, climb and walk frequently and lift up to 50 pounds.
